LAWLESS

1. **IGNORING**:

Let us consider just ONE of the list below – IGNORING harm. Despite the horrendous number of injuries and disabilities caused by the vaccine (1.3 million disabilities in the USA alone), the governments knew this but pushed on relentlessly with the vaccination of babies!
